- 3. Officer Reports:

President: Deferred. Vice President:

a) Submitted resignation prompted by relocation out-of-state.

President:

- a) Accepted nominations to fill the Board vacancy created by Bill's S'. resignation. Jim Keefe was nominated/seconded. Jim gave a brief summary of his background: Former LA County School Board member (Lake Hughes), former HOA president (Lake Oswego, Oregon), former Board of Director's member for Farmer's Group Domestic Carriers in Oregon and Regional Claims Manager for Farmers Insurance Colorado Region (5 states). Brian F. called for a vote/seconded and Jim K. was approved unanimously to fill the board vacancy created by Bill's leaving.
- b) Jim and Joe Felchin both volunteered to fill the vacated Secretary position. Jim was nominated by Kathleen M. (seconded) to fill the vacated position. Brian noted that Joe F. was currently involved in two committees with ongoing projects and recommended that Jim be approved to

allow a better workload distribution. Motion and second to follow that recommendation and Jim was unanimously approved to fill the secretary vacancy.
